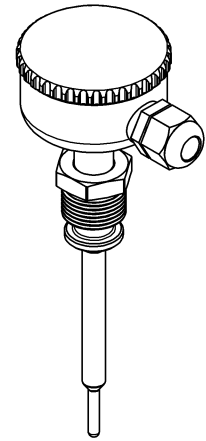


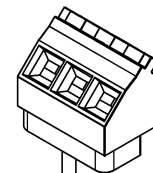
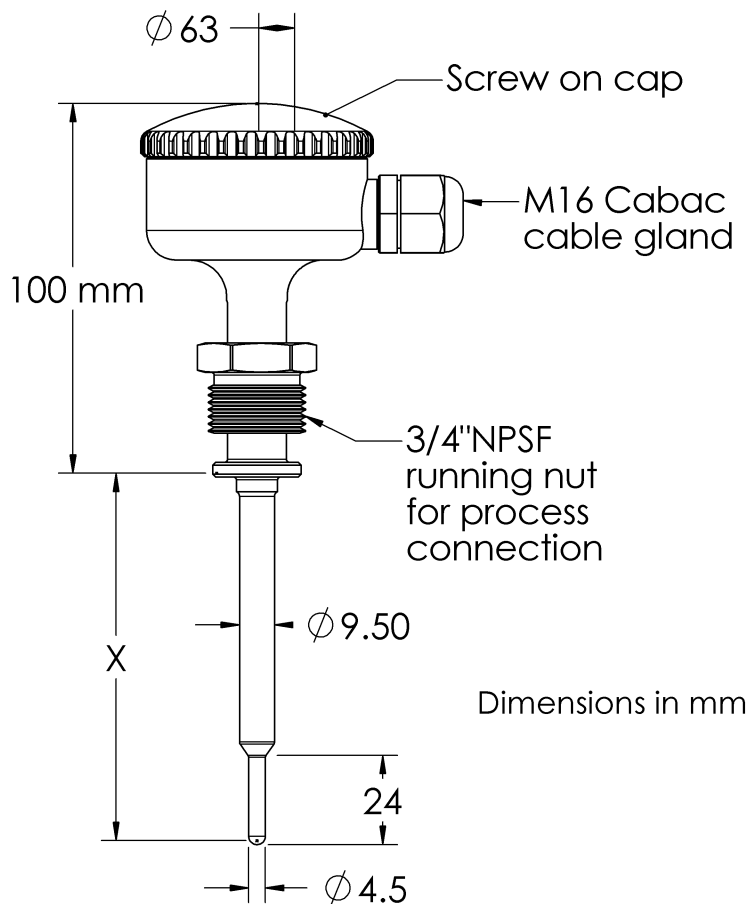
# Azco™ Fast Response Temperature Probe

Note 1 : To achieve full IP66/IP68 ingress protection  
 (A) Use 2 complete turns of thread seal tape on cable gland  
 (B) Tighten cap until seal touches housing and then add 25 degrees of rotation.  
 Note 2 : Tighten connector screws max 0.6 Nm  
 Note 3 : Apply light application of heatsink paste to tip of insert on replacement.
